St. Vincent Pallotti High School, Inc. agrees to enroll the above named student for the 2010/2011 school year and to provide the program and educational and other services as prescribed for that grade.

In consideration of the acceptance of the Enrollment Contract by St Vincent Pallotti High School, Inc., the undersigned agrees to pay the required fees as specified below:

- I. **A non-refundable registration fee and fees specified in Item III below are due by April 1, 2010 with the signed Enrollment Contract.**
 - i. **Registration fee for contracts returned by deadline of April 1, 2010: \$250.**
 - ii. **Contracts received after April 1, 2010 will be assessed a late fee of \$200, making the registration fee \$450.**

II. **Tuition for the 2010/2011 school year is \$12,585. Select one of the following options:**

- _____ **Option #1 - Single Payment Plan**
One payment of \$12,207.45 is due by June 1, 2010. Payments made by the due date receive a 3% discount on the 1st child. (\$12,585.00 - \$377.55 discount = \$12,207.45)
- _____ **Option #2 - Two Payment Plan**
Two payments of \$6,198.11 due June 1, 2010 and November 1, 2010. Option 2 payments made by the due date receive a 1.5% discount on the 1st child. (\$6,292.50 – \$94.39 discount = \$6,198.11)
- _____ **Option #3 – Monthly Automatic Debit Plan (Tuition Insurance Plan required)**
10 monthly payments of \$1,258.50 from June, 2010 through March, 2011. Payments are deducted from either a checking or savings account on specified date each month. Please check below.

Families with two or more children concurrently attending Pallotti will receive a 10% discount equaling \$1,258.50 on each additional sibling’s tuition.

III. **Additional Fees due with enrollment contract by April 1, 2010 (no discounts apply):**

- a. **Student Life Activities Fee:** I (we) understand that each student will be charged an annual \$150.00 Student Life Activities Fee.
- b. **Technology Fee:** I (we) understand that each student will be charged an annual \$100.00 technology fee.
- c. **Junior Retreat Fee:** I (we) understand that all juniors will be charged a \$100 Junior Retreat fee.
- d. **Senior Graduation Fee:** I(we) understand that all seniors will be charged a \$100 graduation fee.

I (we) understand that my (our) obligation to pay tuition and fees for the full academic year is unconditional and that after August 1 no portion of the fees paid or outstanding will be refunded or canceled in the event of absence, withdrawal, or dismissal from the school of the above referenced student.

A late/missed payment fee will be assessed at the rate of \$15.00 for each tuition payment not paid on time. A late fee will be assessed each month until the delinquency has been paid.

St. Vincent Pallotti High School, Inc. reserves the right to legal action for collection of school fees. Return check fees and costs of collection will be added to your account.

In view of this obligation, I understand that the tuition refund plan is being made available to me at this time to protect my yearly financial obligation under the terms of the Enrollment Contract. The program insures fees (prepaid and due) in the event of separation according to the terms of the policy.

I(we) have received and read the enclosed brochure detailing the terms and conditions of coverage concerning this Plan. It is imperative that Box A or B below is checked for each child enrolled. **Note: Parents taking advantage of Option 2 or the monthly payment option are required to participate in the tuition refund plan.**

One box must be checked

A. I(we) wish to participate in the tuition refund plan. The premium rate is 1.2% of the annual tuition fee, equaling \$151.02, payable at time of enrollment. I (we) authorize the school to process and collect any claim payment to which I (we) am (are) entitled under the tuition refund plan and credit it to my (our) account, paying any excess to me (us).

B. I(we) do not wish to participate in the tuition refund plan. I (we) understand that no refund or cancellation of the yearly fees will be made by the school for absence, withdrawal, or dismissal before the end of the school year and herewith agree to assume full responsibility for the full annual tuition and fees.

I(we) understand that in signing this Enrollment Contract for the coming academic year, I(we) agree to accept the rules and regulations of the school as stated in its handbooks and bulletins, the rules concerning payment of fees as referenced above, and to support its faculty and administration. Furthermore, I(we) agree to the policy of the school that no student will be permitted to take examinations nor will grades or transcripts be released unless an account has been paid in full. In addition, I(we) understand that the school has the right to refuse admittance to class, deny athletic participation, refuse graduation and/or transfer of credits for any student whose financial account is delinquent.

Enrollment as specified with this Enrollment Contract, may be canceled by the parents or guardians in writing, without penalty (except for forfeit of the non-refundable registration fee) prior to August 1. If enrollment is canceled after August 1, parents or guardians financially responsible for the student are obligated to pay the full annual charges.

In order to reserve a place for your child, both copies of the Enrollment Contract and your non-refundable registration fee must be received by the School no later than April 1, 2010.

The undersigned agrees to release and hold harmless, the school, its agents and employees from all claims, damages or other liabilities for injuries to my child which are not the result of gross negligence by this school, its agents or employees. The undersigned also agrees to indemnify the school for damages by my child.

This contract shall be interpreted in accordance with the laws of the State of Maryland.
